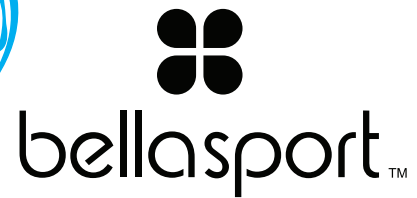
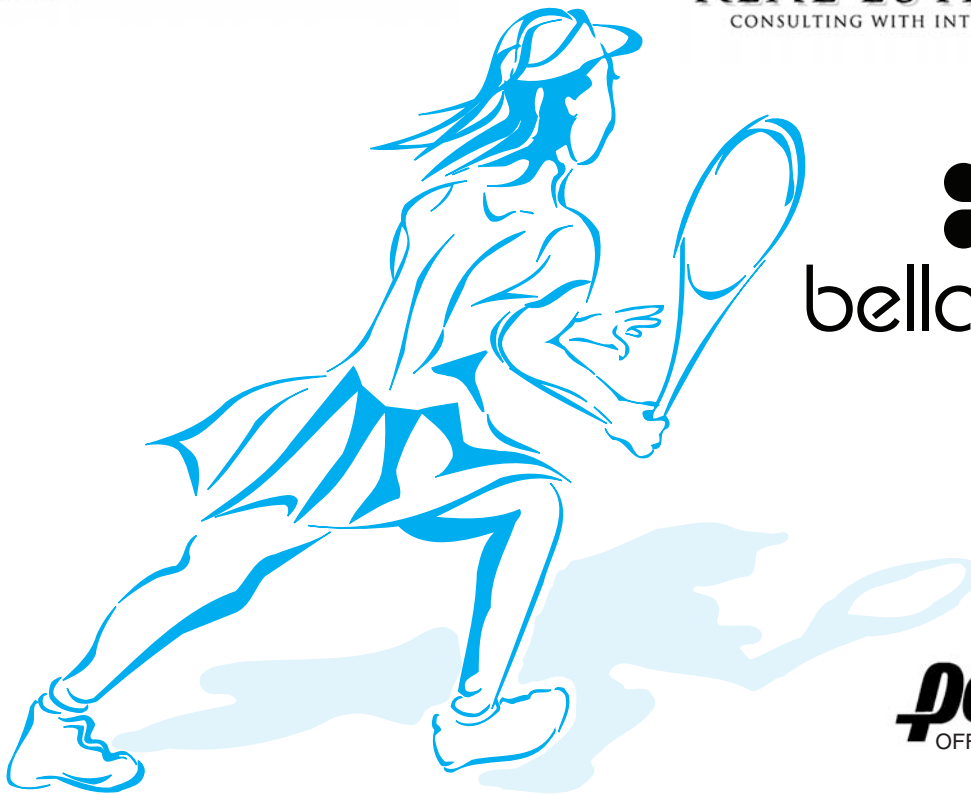

# TOURNAMENT INFORMATION

• **Entry deadline:** August 25, 2006 (sorry no phone entries!) This event will be limited to the first 250 entries. Additional entries will be accepted for the waiting list. Early Bird Special! All entries postmarked on or before August 14, 2006 and on-line entries received by 11:59 PM Pacific Time on August 14, will receive a \$5.00 **total** entry fee discount.

• **To enter on-line:** You will need a current USTA number and a credit card. Go to [www.usta.com](http://www.usta.com). Under **TennisLink**, click on **Tournaments**. In the **Quick Search** box, enter the tournament ID #**651750006**. Click on **Find It!** Click on **Senior Women's Classic**. Once you are in the tournament's home page, click on the red **Register Now** link. Follow the instructions to enter. (Note: The USTA charges a \$2.00 handling fee per event to process your on-line registration.)

• **Players are limited** to one singles event + one doubles event; or two doubles events. Weekday starting times will be between 10:00 A.M. and 7:30 PM (no matches will be scheduled to **start** after 7:30 PM!). Time problems will be

accommodated if possible, but you **must** indicate time problems on your entry form. Players with time problems may only enter **one event**. Working players who wish to enter two events must be available to play the first event by no later than 5:00 PM on weekdays. If in doubt, contact Brad Sceney.

• **Entry Fees:**  
1st Event - \$40 per person  
2nd Event - \$25 per person
